#### **Welcome and Introductions**

Mr. James Campbell, LOSSAN Operations Officer, opened the October 2, 2025, LOSSAN Agency TAC meeting and welcomed the TAC members to the North County Transit District, General Administrative Office Board Room.

Items 3 and 4 were pulled by Mr. Danny Veeh (SANDAG) to comment on the on-time performance improvements. Mr. Veeh then motioned to approve, second by Mr. Christopher Duddy (SDMTS). The Committee approved the Consent items.

#### **DISCUSSION CALENDAR**

#### 6. Pacific Surfliner Equipment & Service Update

Mr. Campbell (LOSSAN) gave a verbal presentation update on the Pacific Surfliner service, which included an update on the planned service levels and statewide equipment needs.

Clarifying questions were asked on future procurements, funding, and the 13th roundtrip. There was no further discussion.

#### 7. Upcoming Draft Board Agenda Ítems

Mr. Campbell provided a brief overview of the agenda items for the November 17, 2025, LOSSAN Agency Board of Directors' meeting.

Questions ensued regarding which agenda items can be brought to the TAC for discussion. There was no further discussion.

#### 8. Los Angeles – San Diego – San Luis Obispo Rail Corridor Agency Update

Mr. Campbell provided an update on the preliminary federal fiscal year 2024-25 ridership for the Pacific Surfliner, which was approximately 2.06 million boardings. Also, there will be a service suspension for all Pacific Surfliner and Metrolink services along the entire corridor for a work window the weekend of October 25<sup>th</sup> and 26<sup>th</sup>.

There was no further discussion.

#### 9. Technical Advisory Committee Members' Report

NCTD mentioned an upcoming service change later in the month, with an updated Coaster schedule.

SANDAG mentioned an agency reorganization and the Del Mar realignment project.

OCTA mentioned using the full corridor work window for the San Juan Creek Bridge replacement project in San Juan Capistrano.

RCTC mentioned the update on the Coachella Valley Rail. RCTC released an RFP for some CEQA environmental work.

VCTC mentioned they are doing an undercrossing project with the City of Camarillo, as well as introducing the new Director in Programming at VCTC.

SBCAG mentioned the City of Goleta's train depot remains on schedule and construction is anticipated to end next summer.

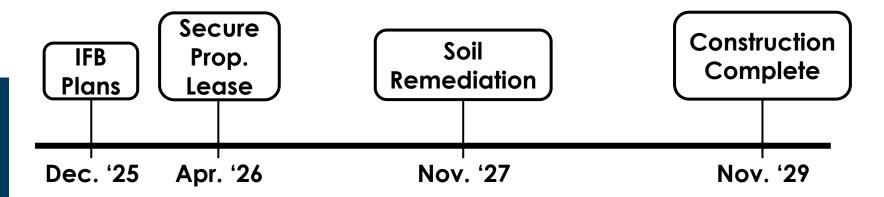

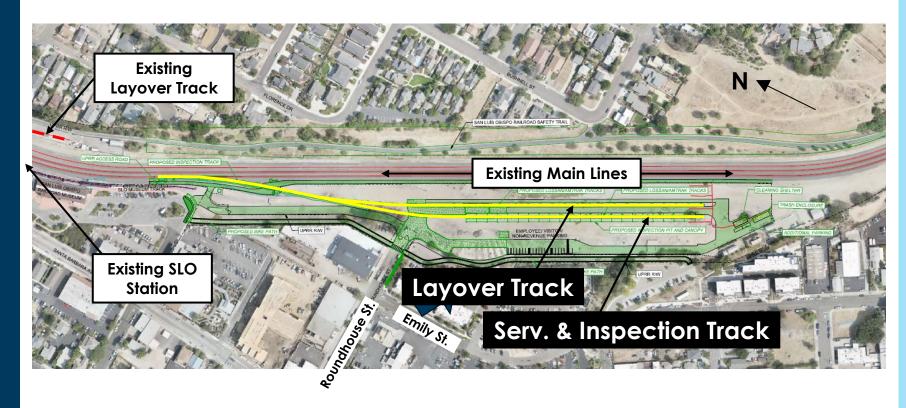




## Central Coast Layover Facility

- Includes a Service & Inspection Track and one (1) Storage Track
- Provides capacity for a 4<sup>th</sup>
   Roundtrip to the City of San
   Luis Obispo
- Final Plans Due:
  - ➤ November 2025
- Projected Construction start:
  - Dependent on Lease Negotiations
- Current project estimate:
  - \$48 million (\$37M Construction)

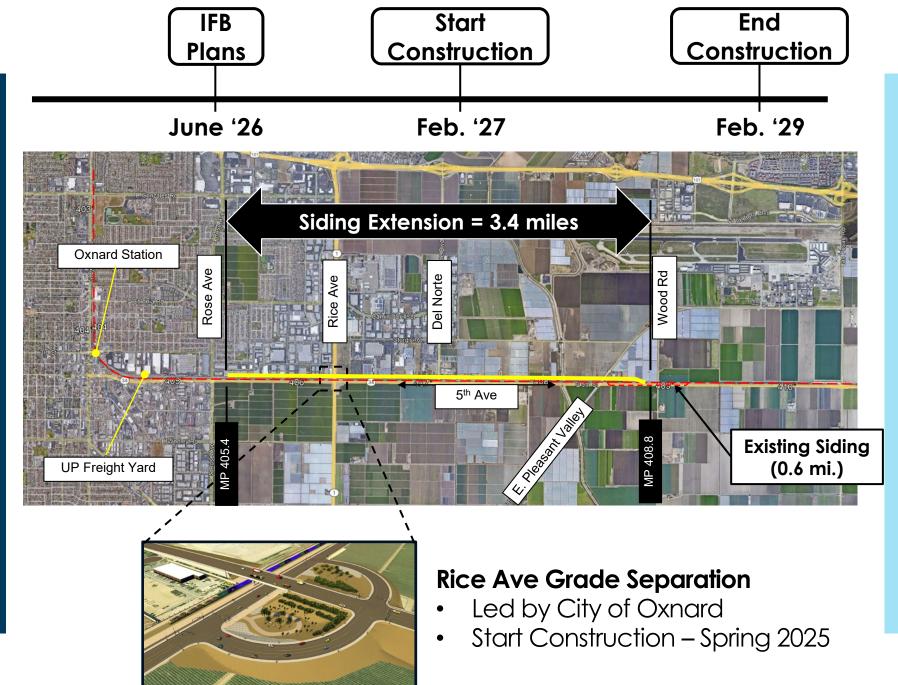






## Leesdale Siding Extension

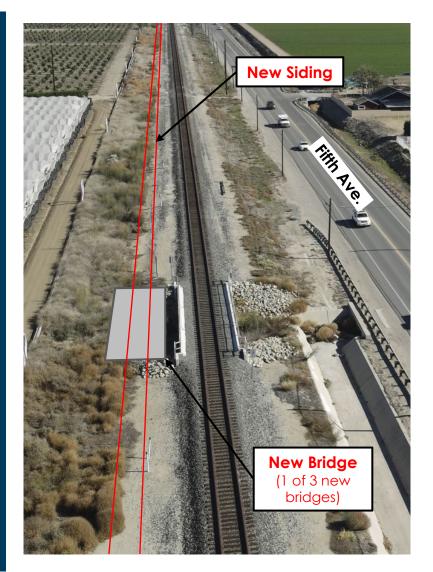
- Includes replacement of the existing Leesdale siding with a siding that is approximately 5.5x longer.
- Reduces wait times for train meets by up to 10 minutes.
- Allows for greater operational flexibility for Pacific Surfliner and Metrolink service.
- Currently at:
  - > 75% Design
- Evaluating challenges through the UPRR review
- Projected Construction start:
  - > Early 2027
- Current project estimate:
  - > \$83 million (\$59M Construction)



## Leesdale Siding Extension

## Other Project Information:

- Replaces / extends approximately 9 culverts
- Adds 3 new bridges
- Upgrades 2 existing at-grade crossings
- Requires relocation of about 3 miles of fiber optic line at an approximate cost of \$10 million

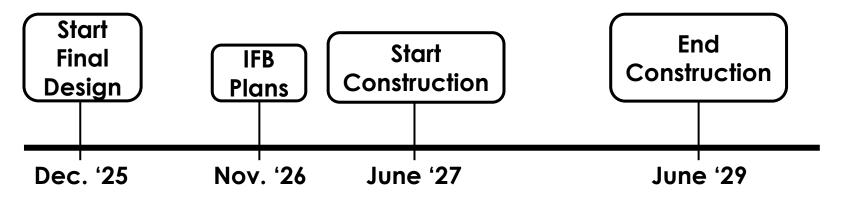


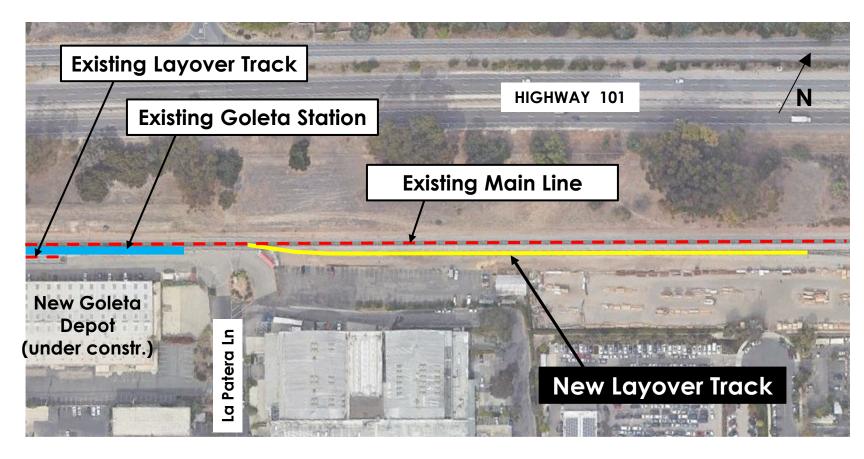




## Goleta Layover Facility Expansion

- Doubles the capacity of existing facility by adding a 2<sup>nd</sup> layover track
- Coordinating with City on their new Station building and parking lot
- Currently at:
  - > 30% Design
- Evaluating challenges through the UPRR review
- Projected Construction start:
  - > Mid 2027
- Current project estimate:
  - > \$14.4 million (\$9.5M Construction)







## Ortega Siding

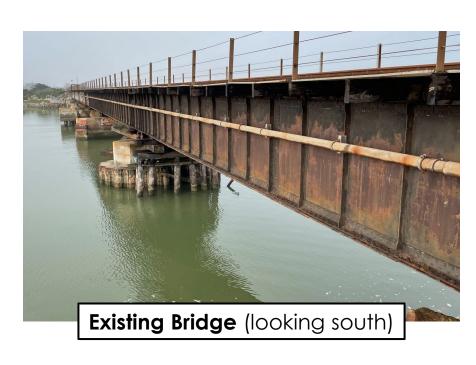
- Located in Santa Barbara County, north of Carpinteria.
- Includes a siding track, improved drainage, and two new bridges for the siding.
- Allows for a 7<sup>th</sup> roundtrip to Goleta
- Highly engaged beach community
- Currently at:
  - > 10% Design
- Current project estimate:
  - > \$33 million (\$19M Construction)





## Santa Ynez River (Surf) Bridge

- 100 years old
- Constricts river flow
- Not to current sea level rise height standards
- Proposed bridge to be triple the length; remove constriction; revitalize estuary
- UPRR was awarded Fish & Wildlife grant to begin initial environmental study
- Currently seeking funding for next phase

- Replaced a 125 year old, steel lattice column bridge
- Columns were erected under live track operation
- A 16-day track outage was required to install the new deck and trackway

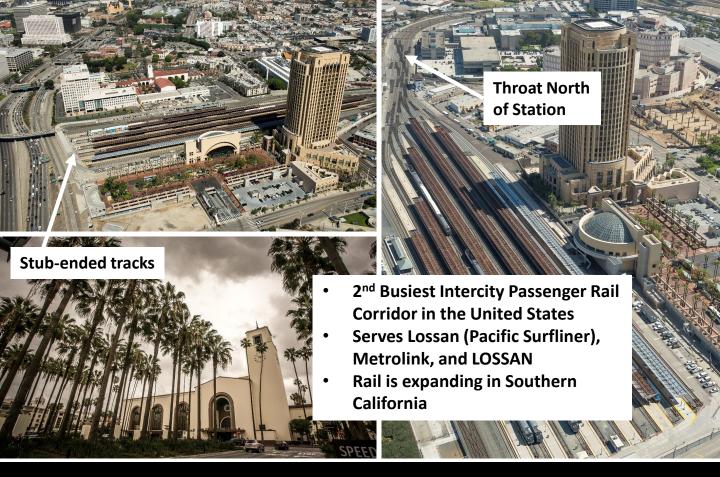

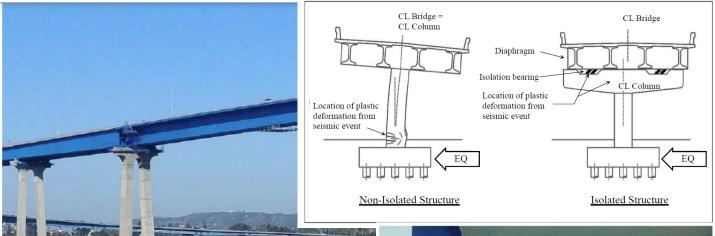

## Run-thru Structure – Isolation Bearings

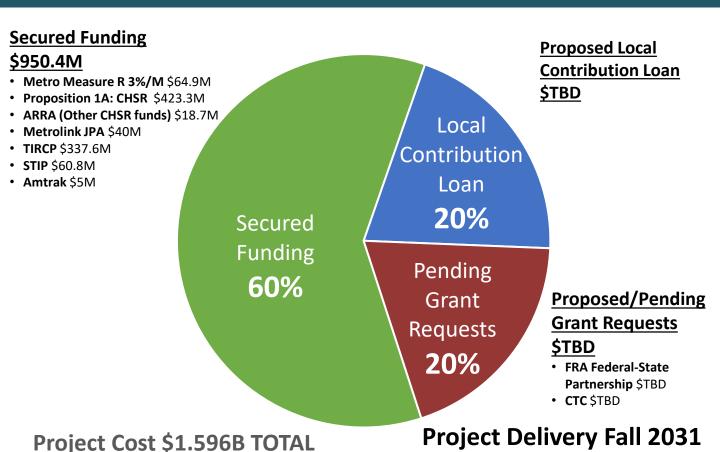


#### Benefits

- Bridge Can Remain in Service after Design Level Earthquake
- Columns and Girders Suffer No Damage after Design Level Earthquake
- Seismic Loads are Dissipated, Resulting in Smaller Pile and Column Sizes


