Welcome and Introductions

The January 18, 2018, LOSSAN Agency TAC meeting was called to order by Mr. Michael Litschi, Deputy Managing Director (LOSSAN), who welcomed the LOSSAN TAC to the Orange County Transportation Authority, 600 South Main Street, Orange, California. Mr. Litschi asked the participants in the room and over the teleconference line for introductions.

Committee members provided comments on the Rail 2 Rail Program, the proposed 13th roundtrip, proposed staff additions, and revenue growth projections. Mr. Litschi informed the committee of the next steps for the development and approval of the Annual Business Plan.

4. Los Angeles – San Diego – San Luis Obispo – Peak Period Service Operating and Service Implementation Plan

Ms. Bergener (LOSSAN) provided a brief overview of the draft operating and service implementation plan for the proposed peak-period service between Los Angeles and Ventura-Santa Barbara counties, including the State's revenue and ridership modeling data for adding the service. Mr. Spaulding (SBCAG) provided comment on the need for peak-period service between Ventura and Santa Barbara counties. There was no further discussion.

5. Transit and Intercity Rail Capital Program Grant Application Update

Mr. Litschi (LOSSAN) provided a brief update to the Committee regarding the grant application process for the 2018 Transit and Intercity Rail Capital Program. Mr. Litschi directed attention to the supplemental information included in the agenda and reviewed the tables with the Committee. There was no further discussion.

6. 2018 Los Angeles – San Diego – San Luis Obispo Rail Corridor Agency Board of Directors Initiatives

Mr. Litschi (LOSSAN) provided a brief overview the 2017 Board of Directors initiatives and opened the discussion for the Committee to provide input on goals. Ms. Bergener also encouraged the Committee to provide input via email before the LOSSAN Board of Directors meeting. There was no further discussion.

7. Upcoming Agenda Items

Mr. Litschi (LOSSAN) provided a brief overview of the agenda items for the January 29, 2018 Board of Directors meeting. There was no discussion.

8. Los Angeles – San Diego – San Luis Obispo Rail Corridor Agency Update

Ms. Bergener (LOSSAN) provided an update on service disruptions north of Los Angeles due to flooding and the efforts being made to provide service to those who needed transportation in and out of the disaster areas. Ms. Bergener expressed thanks to different agencies for their support and cooperation in an effort to help the LOSSAN Agency provide service to passengers. Ms. Bergener informed the Committee of the additional efforts being planned in response to the scheduled work windows impacting travel to the Women's March in San Diego. In addition to the planned bus bridge, additional busses will be brought in to assist with getting passengers to their destination.

Mr. Litschi (LOSSAN) informed the Committee that several memos were sent to the Board of Directors and a press release was issued in response to the service provided during the closure of Highway 101 between Ventura and Santa Barbara counties. Mr. Litschi provided an update on the outreach efforts via social media to inform passengers of the expanded Pacific Surfliner service, and information on the ongoing efforts to continue service while the highway is closed.

A brief discussion ensued with the Committee members asking clarifying questions regarding equipment and expected timeline for the continued support.

9. Technical Advisory Committee Members' Report

Ms. Miller (VCTC) expressed thanks to the LOSSAN Agency staff for continuing to work toward providing additional capacity for trains north of Los Angeles in response to the mudslides.

Mr. Spaulding (SBCAG) echoed Ms. Miller's comments regarding the ongoing efforts, informed the committee of the efforts being made to provide bus service to help health professionals and teachers get to and from their places of employment.

Mr. Rodgers (SLOCOG) informed the Committee of items that will be discussed at the Coast Rail Coordinating Council meeting on January 30, 2018.

Mr. Fuhrman (Metro) informed the Committee of the additional Metro and Metrolink service planned in the Los Angeles area for the Women's March.

Mr. Veeh (SANDAG) provided an update on the Oceanside Transit Center platform project.

CENTRAL COAST LAYOVER FACILITY AND STATION EXPANSION

SUMMARY

The existing single track layover facility is located directly across from the San Luis Obispo Pacific Surfliner station. The project includes three phases. 1) Project Approval & Environmental Documents including conducting California Environmental Quality Act and if applicable, National Environmental Policy Act environmental reviews, 2) preparation of Plan, Specifications & Estimates (PS&E), and 3) Construction of three thousand feet (.57 mile) of additional layover track, or the rehabilitation of 1,000 feet of track and construction of 2,000 feet of track depending on the outcome of the environmental studies. The Pacific Surfliner would be able to improve the ridership and revenue of intercity rail passenger service through additional layover capacity. The project will facilitate the maintenance of equipment mid-route and at route terminus. It would allow additional passenger trains to hold overnight and allow a second more convenient morning departure from San Luis Obispo. It would also provide a facility to hold and service a train set used for the proposed expansion of the Pacific Surfliner.
