Welcome and Introductions

Mr. James Campbell, LOSSAN Operations Officer, opened the March 7, 2024, LOSSAN Agency TAC meeting and welcomed the TAC members to Los Angeles County Metropolitan Transportation Authority, in the Henry Huntington Room.

Mr. Aubrey Smith (VCTC) motioned to approve the items, seconded by Mr. Peter Casellini (SANDAG). The Committee approved the Consent items.

DISCUSSION CALENDAR

4. Fiscal Year 2023-24 First Quarter Amtrak Pacific Surfliner On-Time Performance Analysis

Mr. Kristopher Ryan (LOSSAN) provided a presentation of the Pacific Surfliner On-Time performance analysis for the first quarter of federal fiscal year 2023-24, which included the monthly average customer on-time performance, delays, and improvements.

A discussion ensued regarding the impact on assaults and vandalism on delays. There was no further discussion.

5. Pacific Surfliner Marketing Update

Ms. Puja Thomas-Patel (LOSSAN) presented the second quarter of fiscal year 2023-24 marking update, which includes the performance summary, marketing updates, upcoming campaigns, and influence partnerships.

A discussion ensued regarding special event service and partnerships around the X Games. There was no further discussion.

6. Pacific Surfliner Service Update

Mr. Campbell provided a verbal update on the resumed limited service through San Clemente, totaling five roundtrips, which includes bus bridges between Los Angeles to San Diego. Mr. Campbell also mentioned the Del Mar Bluff work, including future closures for the springtime.

A discussion ensued regarding the increase in service. There was no further discussion.

7. Upcoming Draft Board Agenda Ítems

Mr. Campbell (LOSSAN) provided a brief overview of the agenda items for the March 18, 2024, LOSSAN Agency Board of Directors' meeting.

There was no further discussion.

8. Los Angeles – San Diego – San Luis Obispo Rail Corridor Agency Update

An update was provided on the ridership, including the suspension of service through South Orange County. Mr. Campbell also mentioned a fleet deployment meeting with Caltrans and San Joaquins staff held earlier that morning, followed by an initial stakeholder meeting with Caltrans on the Corridor ID Program.

There was no further discussion.

9. Technical Advisory Committee Members' Report

Mr. Aaron Bonfilio (SBCAG) mentioned the allocation request with CTC for construction funding for the Goleta train depot and the CalSTA reached out to have SBCAG host the next LOSSAN Regional Rail Working Group meeting later this spring.

Aubrey Smith (VCTC) mentioned the update X Games and a brief update on the Camarillo station ADA improvement project.

Mr. Sheldon Peterson (RCTC) mentioned the Coachella Valley Rail Project selection in the Corridor ID Program.

Ms. Megan Taylor (OCTA) announced that Angel Express service resumes beginning March 26th.

Mr. Peter Casellini (SANDAG) mentioned work has started on the Del Mar Bluff Phase 5 Stabilization project and continues on the Del Mar Tunnel project.

Mr. Lijia Zhang (HSR) submitted a written update stating: A draft 2024 Business Plan was issued on February 9, 2024, with a 60-day public comment period that will run through April 9, 2024. The 2024 Business Plan will be considered by the Authority Board of Directors on Wednesday, April 11, 2024. In compliance with CPUC 185033, the Business Plan is updated biennially (in even years), and in the intervening odd years, CHSRA will issue Project Update Reports. Also, for the LA to Anaheim project section, CHSRA plans to seek board approval for the Preferred Alternative in April. This will involve deciding whether to include interim station(s) between LinkUS and Anaheim, as well as determining the location of the LMF

Pacific Surfliner Equipment Update

Pacific Surfliner Equipment

- The Pacific Surfliner service has been utilizing bi-level cars since 2000
- 39 custom Surfliner cars were purchased new by Amtrak and 10 cars by the California Department of Transportation (Caltrans) between 1998-2001 for specific use on the Pacific Surfliner service
- Over the years, as ridership grew, additional cars were needed to lengthen trainsets and add more service
- The additional cars were leased from Amtrak's long-distance bi-level Superliner and regional single-level Horizon fleets

Pacific Surfliner Equipment Reduction

March 2020 - ridership dropped significantly due to the COVID-19 pandemic.

Level of service was reduced 50-percent

Fleet size was reduced 29percent

California Intercity Passenger Car History


There has been a need for additional equipment since before to the COVID pandemic

In 2017, Caltrans placed an order for seven 7-car trainsets of the new Siemens, single-level Venture cars.

- Various issues have delayed deployment by several years.
- First coach cars began going into revenue service in December 2023
- Cab cars are not anticipated to be in service until at least July 2024
- Food service cars are not expected to be in service until July 2025.



California Equipment Redeployment Plan A fleet redeployment plan for the existing Surfliner and California 1 bi-level equipment was developed in originally in 2022 and was updated earlier in 2024.





California Equipment Redeployment Plan

The update made to the plan in 2024 was to account for delays, as well as several additional overhaul projects and equipment work that was not included in the original plan prepared in 2022.

This included:

- Adjustment to reflect further delay in Venture car deployment
- Truck and door overhaul programs necessary for the state-owned bi-level cars to remain in SOGR
- Extensive rebuilding of some bi-level cars due to incidents that have occurred over the past two years, which have taken some cars out of service

Deployment of Venture cars enables an increase of four trainsets – enough to restore pre-pandemic service levels





Equipment Needs for Service Growth

Options for expanding service and capacity beyond pre-pandemic service is limited in the near-term.

Options being considered include:

- Evaluate the feasibility of procuring four additional 7-car trainsets of the new Siemens, single-level Venture cars
- Work with Caltrans to develop specifications for a new bi-level procurement
- Identify segments of corridor where procured ZEMU's can operate to meet demand





Central Coast Layover Facility

- Expansion and relocation of existing layover facility.
- Goal is to improve layover and storage capacity to support rail service goals.
- EIR Certified by LOSSAN Board in December 2022.
- Project has completed 60percent design.
- Current project estimate -\$41.5 million



Central Coast Layover Facility






Goleta Layover Facility Expansion

- Includes construction of an additional layover track to double the size of the servicing capacity.
- 30-percent design has been reviewed by UPRR
- Design Consultant to respond and move forward to 90-percent milestone
- Current project estimate -\$14.4M








Leesdale Siding Upgrade and Expansion

- Includes replacement of the existing Leesdale siding with a siding that is approximately 3x longer.
- Reduces wait times for train meets by up to 10 minutes.
- Allows for greater operational flexibility for Pacific Surfliner and Metrolink service.
- 10-percent design is in review with UPRR
- Current Project Estimate -\$69.5 million









Ortega Siding

- Located in Santa Barbara County, north of Carpinteria.
- Project includes construction of a siding track, signalized CTC with powered turnouts, improved drainage, and new bridges for the siding.
- RFP for Preliminary
 Engineering and Design
 anticipated at June Board
 meeting
- Current Design estimate is \$2.7M with a total project estimate of \$33.1M
