### **4. Link Union Station Project Update**

Mr. Campbell introduced LA Metro's Scott McConnell, Regional Rail Executive Officer, who provided a PowerPoint presentation on the Link US Project updates. The presentation included the substation layout, the run-thru structure goal, program schedule, and project cost and funding.

*Questions ensued regarding possible project impacts. There was no further discussion.*

### **5. Capital Program Update**

Mr. Campbell introduced Mr. David Berryman (LOSSAN), who provided a PowerPoint presentation on the current stats and projects along the LOSSAN rail corridor. The presentation included current and completed capital projects.

*Questions ensued regarding the structure and funding roles on specific projects. There was no further discussion.*

### **6. Upcoming Draft Board Agenda Items**

Mr. Campbell provided a brief overview of the agenda items for the November 17, 2025, LOSSAN Agency Board of Directors' meeting.

*Minor clarification questions ensued regarding some agenda items. There was no further discussion.*

### **7. Los Angeles – San Diego – San Luis Obispo Rail Corridor Agency Update**

Mr. Campbell provided an update on October ridership, the Dodger's World Series Victory parade with strong and high ridership for that day, and the start of the Pacific Surfliner Happy Hour promotion from 8pm to closing, as well as the checked baggage option during the holiday season. Work windows were also mentioned for January.

*Minor questions ensued regarding the promotions and ridership. There was no further discussion.*

### **8. Technical Advisory Committee Members' Report**

*Metro mentioned the LA Dodgers World Series parade, which brought over 300,000 to the parade and another 50,000 to the Dodger stadium, which caused over capacity trains and over 11,000 standees. The situation has definitely caused internal discussion on how to prepare for the upcoming World Cup and LA28 events.*

*SANDAG mentioned two construction projects along the corridor, a regional plan for a full double track within San Diego County, as well as considering applying for a federal state partnership program. Also, SANDAG mentioned the upcoming 2026 California Passenger Rail Summit in April.*

*Caltrans mentioned the plan to release Step Two on the corridor ID program soon.*
